HOSTAGE RELEASE

This headline instantly draws attention internationally but <u>especially</u> by family members of each hostage. Prison ministry volunteers receive basic training to survive in the event of a potential hostage-taking situation. Yet, minimal preparation precedes a person who is arrested and held for an indeterminate period of time behind bars. Each inmate is *on his own*. It is easy for outsiders to repeat platitudes like, "You do the crime—you do the time" or quote a Bible verse like my favorite in the King James, "count it all joy when ye fall into **divers** temptations" (James 1:2). A poor swimmer, I avoid diving boards. Ill-equipped, most ministry workers do a lousy to fair job as inmate life coaches teaching effective survival skills without having personally walked a single step in their moccasins.

On a less severe level, a drafted soldier is similar in that his life is predetermined by the military with few to zero options.

Going AWOL means the brig and dishonorable discharge with lifetime consequences. It is somewhat like living with a felony conviction on your permanent record. In combat, the soldier faces death daily, serious injury, or being captured and taken as a POW. It has been said that "War is Hell." It is not surprising to hear prisoners describe life in a penitentiary as "Hell." When released—under the best conditions—escapees battle ongoing depression, nightmares, suicidal thoughts and other by-products of post-traumatic stress disorder.

Active county jail ministries are few and limited time is allowed to prepare inmates for the present, let alone future. A ministry is like a Volunteer Fire Department. Willing firemen rush into the flames to pull out those Satan has taken "captive to do his will"

(Jude 22-23; Second Timothy 2:26). Trauma is inescapable even if held captive briefly and then, rescued. A few will remain in a county jail longer than many are in prison. In prison, little is done effectively to prepare offenders to serve 2, 5, 10 or 50 years. The death sentence is rarely carried out but that is a different topic.



Dr. Dale Underwood, NLBM President, is in the process today of producing a much-needed **Re-Entry** course. - Warmly received into a loving home (spouse, parents, children, siblings).
- Resuming stable employment in your chosen career.

- Becoming an integral participant in a strong support group.
- Having supportive relationships (friends/mentors) who hold up your hands and hold you accountable.
- Expectation of you to accept personal responsibility for accomplishing meaningful tasks.

Pray for the **Re-Entry** course to prove extremely beneficial in thousands of lives of hostages released daily throughout the United States. Express thanks to the Lord for Dr. Underwood's wisdom, rich background, experience, dependency on God,

and God-given writing talent to put these 13 lessons together in ways that bless each hostage exposed to their content. In hindsight, may the "why" behind first being arrested or "apprehended" (like Saul of Tarsus in Philippians 3:12) be clearly viewed as the "providence" of God. It is empowering when we can see that our Father's hand has always been outstretched to us.



TEXAS PANHANDLE INITIATIVE FURTHER DETAILS

You need to know that the *target area* is broader than one label can communicate. For instance, if living in the Abilene area, you would say you are in **West Texas**. But if we referred to this initiative as *West Texas*, those in

Dalhart would think it does not apply to them. Texas Department of Corrections, however, operates according to "regions" which places prisons in Dalhart, Amarillo, Tulia, Borger, Colorado City, Childress, Iowa Park, Lamesa, Pampa, Plainview. Snyder, and Lubbock in **Region V**. But if we called this the <u>**Region 5 Initiative**</u>, volunteers in **Region 6** (Abilene, Sweetwater, Hamlin, Merkel and Rotan would conclude that this initiative is not a concern to them. But these five cities are within 35 to 80 miles from some "Region 5" prisons. Texas is a BIG state, so miles do not have the same meaning as in smaller states. For instance, our volunteers in Corpus Christi drive to a nearby prison 30 miles away, another is 50 miles, one is 70 miles, and still another is 130 miles away.

Dr. Dale Underwood has been privileged to attend the TDCJ chaplains' annual Spring gathering the last two years in Huntsville. He will also be making a presentation at this year's event and take our display of materials. The Pegian 5 chapleing are easer to have the Newl if Peder
